

Constitution

Part 1 - Preliminary

1. Name

The Company is ABx Group Limited.

2. Nature of Company

The Company is a public company limited by shares.

3. Replaceable rules

The replaceable rules in the Corporations Act 2001—do not apply to the Company.

4. Listing Rules

If the Company is admitted to the official list of ASX:

- 4.1 notwithstanding anything contained in this constitution, if the Listing Rules prohibit an act being done, the act must not be done;
- 4.2 nothing contained in this constitution prevents an act being done that the Listing Rules require to be done;
- 4.3 if the Listing Rules require an act to be done or not to be done, authority is given for that act to be done or not to be done (as the case may be);
- 4.4 if the Listing Rules require this constitution to contain a provision and it does not contain such a provision, this constitution is deemed to contain that provision;
- 4.5 if the Listing Rules require this constitution not to contain a provision and it contains such a provision, this constitution is deemed not to contain that provision;
- 4.6 if any provision of this constitution is or becomes inconsistent with the Listing Rules, this constitution is deemed not to contain that provision to the extent of the inconsistency.

Part 2 - Shares

5. Issue of shares

Without limiting the Company's powers under the Corporations Act—2001, the Company (under the control of the Directors) may:

- 5.1 issue shares in the Company; and
- 5.2 grant options or rights over unissued shares in the Company;

on any terms, with any rights or restrictions attached to the shares, at any time, and for any consideration the Directors decide.

6. Preference shares

- 6.1 The Company may issue preference shares on terms approved by special resolution of the Company as to:
 - 6.1.1 repayment of capital;
 - 6.1.2 participation in surplus assets and profits;
 - 6.1.3 cumulative and non-cumulative dividends;
 - 6.1.4 voting;
 - 6.1.5 priority of payment of capital and dividends in relation to other shares or classes of preference shares.
- 6.2 The Company may issue new preference shares that rank equally with existing preference shares. A new issue is taken not to vary the rights attached to the existing preference shares.
- 6.3 The Company may only redeem redeemable preference shares according to their terms of issue.

7. Variation of classes and class rights

- 7.1 Subject to the Corporations Act 2001, the Company may:
 - 7.1.1 vary or cancel rights attached to shares in a class of shares;
 - 7.1.2 convert shares from one class to another;

by special resolution of the Company and

- 7.1.3 by special resolution passed at a meeting of the holders of shares in that class; or
- 7.1.4 by the written consent of shareholders with at least 75% of the votes in that class.
- 7.2 Part 5 (with the necessary changes) applies to meetings of holders of a class of shares.
- 7.3 The Company may issue new shares that rank equally with existing shares. The new issue is taken not to vary the rights attached to the existing shares.

8. Alteration of share capital

The Company in general meeting may convert its shares into a larger or smaller number of shares.

9. Reduction of capital and buy-backs

Subject to the Corporations Act 2001 and the Listing Rules, the Company may:

- 9.1 reduce its share capital:
- 9.2 buy-back shares in itself.

10. Brokerage

The Company may pay brokerage or commission if a person takes up shares in the Company.

11. Joint holders

- 11.1 2 or more persons may hold a share only as joint tenants.
- 11.2 Subject to the Corporations Act 2001 and the Listing Rules, the Company need not register more than 3-four persons as joint holders of a share.

12. Trust not recognised

Except as required by law or this constitution, the Company need not recognise:

- 12.1 that a person holds a share on trust; or
- 12.2 any interest in a share except the registered holder's absolute ownership of the whole share.

13. Non-Marketable Parcels

- 13.1 If one or more Members hold less than a Marketable Parcel of shares, the Directors may invoke the procedure for the sale of shares under this clause 13 ('Procedure').
- 13.2 To invoke the Procedure, the Directors must give each Member who holds less than a Marketable Parcel of shares ('Eligible Member') written notice ('Notice of Divestiture') that complies with this clause 13.
- 13.3 A Notice of Divestiture given to a Member must:
 - 13.3.1 state that the shares referred to in the Notice of Divestiture are liable to be sold in accordance with the Procedure if the Member does not advise the Company before a specified date ('Relevant Date') that the Member wishes to keep those shares; and
 - 13.3.2 if the Member holds shares in a CHESS Holding, contain a statement to the effect that if those shares remain in a CHESS Holding after the Relevant Date, the Company may, without further notice, move those shares from the CHESS Holding to an Issuer Sponsored Holding or a Certificated Holding for the purposes of divestment by the Company in accordance with the Procedure.
- 13.4 The Relevant Date must be six weeks or more after the date that the Notice of Divestiture is sent.
- 13.5 For so long as the Company is admitted to the official list of ASX, a copy of a Notice of Divestiture must be given to any other person required by the ASX Settlement Operating Rules.
- 13.6 If an Eligible Member on whom a Notice of Divestiture has been served, wants to keep the shares referred to in the Notice of Divesture, the Eligible Member must give the Company written notice before the Relevant Date, advising the Company that the Member wants to keep those shares or the member must increase their holding of shares

- before the Relevant Date to a Marketable Parcel in each of which events the Company will not sell the shares.
- 13.7 Any shares which may be sold under this clause 13 may be sold on the terms, in the manner (whether on-market, by private treaty, through a share sale facility established by, on behalf of, or at the request of the Company, or otherwise) and at the time or times determined by the Directors and, for the purposes of a sale under this clause 13, each Eligible Member:
 - 13.7.1 appoints the Company as the Eligible Member's agent for sale and to receive any disclosure document, including a financial services guide;
 - 13.7.2 authorises the Company to effect on the Eligible Member's behalf a transfer of the shares sold and to deal with the proceeds of the sale of the shares in accordance with clause 13.9;
 - 13.7.3 appoints the Company, its Directors and Secretaries jointly and severally as the Eligible Member's attorneys to execute any instrument or take other steps, in the Eligible Member's name and on the Eligible Member's behalf, as they or any of them may consider appropriate to transfer the shares sold; and
 - 13.7.4 authorises each of the attorneys appointed under clause 13.7.3 to appoint an agent to do a thing referred to in clause 13.7.3.
- 13.8 The title of the transferee to shares acquired under this clause 13 is not affected by an irregularity or invalidity in connection with the sale of shares to the transferee.
- 13.9 The proceeds of any sale of shares under this clause 13 less any unpaid calls and interest ('Sale Consideration') will be paid to the relevant Member or as that Member may direct.
- 13.10 The Company will hold the Sale Consideration in trust for the Member whose shares are sold under this clause and will forthwith notify the Member in writing that the Sale Consideration in respect of the Member's shares has been received by the Company and is being held by the Company pending instructions from the Member as to how it is to be dealt with. If the Member has been issued with a share certificate or certificates, the Member's instructions, to be effective, must be accompanied by the share certificate or certificates to which the Sale Consideration relates or, if the certificate or certificates has or have been lost or destroyed, by a statement and undertaking under subsection 1070D(5) of the Corporations Act.
- 13.11 Subject to the Corporations Act, the Company or the purchaser will bear all costs, including brokerage and stamp duty, associated with the sale of any shares under this clause.
- 13.12 A Notice of Divestiture under clause 13.2 may only be given once in any 12 month period and may not be given during the offer period of a takeover bid for the Company.

- 13.13 If the Procedure has been invoked and there is an announcement of a takeover bid for shares, no more sales of shares may be made under this clause 13 until after the close of the offers made under the takeover. The Procedure may then be invoked again.
- 13.14 The Directors may, before a sale is effected under this clause 13, revoke a Notice of Divestiture or suspend or terminate the Procedure, either generally or in specific cases.
- 14.0 If at any time the number of Shares registered in the name of a Member is less than a Marketable Parcel and those Shares are held on the certificated subregister ('Eligible Member'), the Directors may cause a written notice ('Notice') to be despatched to the Eligible Member, requiring the Eligible Member to advise the Company by a specified date ('Relevant Date') whether the Eligible Member elects that the provisions of this Clause are not to apply to the Shares.
- 15.0 The Relevant Date must be not less than six weeks after the date of service of the Notice.
- 16.0 At least four weeks before the Notice being despatched the Directors must cause a notice to be despatched to each Member who holds an Uncertificated Holding which is less than a Marketable Parcel, advising each of those Members of the Directors' intention to invoke the procedure provided for in this Clause 13 ('Procedure').
- 17.0 That notice must state that if the Member wishes to have its holding sold in accordance with the Procedure it will be necessary, for that Member to effect or arrange for conversion of its holding from uncertificated to certificated mode before a specified date, being the date on which the Directors intend to invoke the Procedure.
- 18.0 At the time the Procedure is invoked a Notice must be despatched to each and every Eligible Member.
- 19.0 The Notice must state that the Shares referred to in the Notice will be liable to be sold unless, by the Relevant Date:
 - 20.0.0 the Member advises the Company that the provisions of this Clause are not to apply to the Shares; or
 - 21.0.0 the Member's holding has been converted from certificated to uncertificated mode.
- 22.0 Every Eligible Member on which a Notice has been served may by notice in writing addressed to the Secretary and delivered to the Office before the Relevant Date require the Company not to sell that Member's Shares in accordance with this Clause in which event no sale of that Member's Shares will take place.
- 23.0 If the Eligible Member does not advise the Company by the Relevant Date that the provisions of this Clause are not to apply to the Shares referred to in the Notice, any of those Shares which are held in certificated mode as at the Relevant Date may be sold by the Company.

- 24.0 Any Shares which may be sold pursuant to this Clause may be sold on the terms, in the manner and at the time determined by the Directors and for the purposes of a sale pursuant to this Clause each Eligible Member:
 - 25.0.0 appoints the Company the Eligible Member's agent for sale:
 - 26.0.0 authorises the Company to effect on the Eligible Member's behalf a transfer of the Shares sold:
 - 27.0.0 appoints the Company and its Directors jointly and severally as the Eligible Member's attorneys in the Eligible Member's name and on the Eligible Member's behalf to execute any instrument or take any other steps as they or any of them may consider appropriate to transfer the Shares sold.
- 28.0 The title of the transferee to Shares acquired pursuant to this Clause is not affected by any irregularity or invalidity in connection with the sale of Shares to the transferee.
- 29.0 The proceeds of any sale of Shares pursuant to this Clause less any unpaid calls and interest ('Sale Consideration') will be paid to the relevant Member or as that Member may direct.
- 30.0 The Sale Consideration received by the Company in respect of all Shares sold pursuant to this Clause will be paid into a bank account opened and maintained by the Company for the purposes of this Clause.
- 31.0 The Company will hold the Sale Consideration in trust for the Member whose Shares are sold pursuant to this Clause and will forthwith notify the Member in writing that the Sale Consideration in respect of the Member's Shares has been received by the Company and is being held by the Company pending instructions from the Member as to how it is to be dealt with. Unless the Member has waived any entitlement it may have to a share certificate or certificates, the Member's instructions, to be effective, must be accompanied by the share certificate or certificates to which the Sale Consideration relates or, if the certificate or certificates has or have been lost or destroyed, by a statement and undertaking pursuant to subsection 1070D of the Corporations Act 2001...
- 32.0 Subject to the Corporations Act, the Company or the purchaser will bear all costs, including brokerage and stamp duty, associated with the sale of any shares pursuant to this Clause.
- 33.0 The Procedure may only be invoked once in any 12 month period after its adoption or renewal.
- 34.0 If the Procedure has been invoked and there is an announcement of a takeover offer or takeover announcement for Shares, no more sales of Shares may be made pursuant to this Clause 13 until after the close of the offers made under the takeover offer or takeover announcement. The Procedure may then be invoked again.

- 35.0 For the purposes of this Clause 13:
 - 36.0.0 **Marketable Parce**l has the same meaning as in the Listing Rules;
 - 37.0.0 **Uncertificated Holding** means a holding of Shares which is not held on any certificated sub-register maintained by or on behalf of the Company."

38.14. Share and option certificates and CHESS statements

- 38.114.1 When the Company registers securities of any class to a shareholder or option holder, the Company must issue to the shareholder or option holder, without charge, in the discretion of the Directors:
 - 38.1.114.1.1 one or more certificates for those securities;
 - 38.1.214.1.2 a statement of holdings required by the CHESS ASX Settlement Operating Rules; or
 - 38.1.314.1.3 any other document that confirms ownership of the securities as the Directors decide.
- 38.214.2 If the Corporations Act 2001 so permits, the Company:
 - 38.2.114.2.1 need not issue a certificate for the securities;
 - 38.2.214.2.2 may cancel a certificate and not issue a replacement.
- 38.314.3 The Company must comply with the Corporations Act 2001 and the Listing Rules in issuing those certificates, statements of holdings or other documents.
- 38.414.4 If required to issue a certificate, the Company need issue only one certificate for securities registered in more than one name. The Company must deliver that certificate to any one of the registered holders.
- 38.514.5 Subject to the Corporations Act 2001 and the Listing Rules, the Company must issue a replacement certificate for a defaced, worn out, lost or destroyed certificate.

39.15. Restricted securities

- 39.115.1 Notwithstanding any other provision in this constitution:
 - 39.1.115.1.1 restricted securities cannot be disposed of during the escrow period except as permitted by the Listing Rules or ASX;
 - 39.1.2 the Company must refuse to acknowledge a disposal (including registering a transfer) of restricted securities during the escrow period except as permitted by the Listing Rules or ASX:
 - 39.1.3 during a breach of the Listing Rules relating to restricted securities, or a breach of a Restriction Agreement, the holder of the restricted securities is not entitled to any Dividend or distribution, or voting rights, in respect of the restricted securities.
- 39.215.2 In this clause:

- 39.2.115.2.1 **dispose** has the same meaning as in the Listing Rules;
- 39.2.215.2.2 restricted securities has the same meaning as in the Listing Rules.

Part 3 - Calls, liens and forfeiture

40.16. Calls

- 40.116.1 Subject to the Listing Rules and the terms of issue, the Directors may make calls on the holder of a share for any unpaid portion of the issue price of that share at any time.
- 40.216.2 The Directors may make a call payable by instalments.
- 40.316.3 While the Company is admitted to the official list of ASX, the Directors must give to the shareholder:
 - 40.3.1 the period of notice of the call required by the Listing Rules; and
 - 40.3.216.3.2 a call notice containing the information required by the Listing Rules.
 - While the Company is not admitted to the official list of ASX, the Company must give to the shareholder at least 14 days' notice of a call, specifying the amount payable, and the time and place of payment.
- 40.416.4 A call is made when the Directors resolve to make the call.
- 40.516.5 The Directors may revoke or postpone a call or extend the time for payment.
- 40.616.6 A call is still valid if either or both:
 - 40.6.116.6.1 a shareholder does not receive notice of the call;
 - 40.6.216.6.2 the Company accidentally does not give notice of the call to a shareholder.
- 40.716.7 A shareholder must pay to the Company:
 - 40.7.116.7.1 the amount called, by the time and at the place specified;

- 71.442.4 The parent or guardian of an infant shareholder may vote that infant's share, if the parent or guardian satisfies the Directors of the relationship or appointment before the meeting. If the infant's parent or guardian votes the share, the infant shareholder must not vote.
- 71.542.5 A person may vote a share if:
 - 71.5.142.5.1 the person is entitled to be registered as the holder of the share because of a Transmission Event; and
 - 71.5.242.5.2 the person satisfies the Directors of that entitlement before the meeting.

The shareholder must not vote a share if another person does so under this sub-clause.

73.44. Proxies, attorneys and representatives

73.144.1 A shareholder, who is entitled to vote at a meeting of shareholders, may vote:

73.1.144.1.1 on a show of hands:

- (a) personally;
- (b) by one proxy;
- (c) by one attorney; or
- (d) if a body corporate, by its representative, or by one proxy or by one attorney;

73.1.244.1.2 on a poll:

- (a) personally;
- (b) by not more than 2 proxies;
- (c) by not more than 2 attorneys; or
- (d) if a body corporate, by its representative, or by not more than 2 proxies or by not more than 2 attorneys.
- 73.244.2 A proxy, attorney or representative need not be a shareholder of the Company.
- 73.344.3 A shareholder may appoint a proxy, attorney or representative for all or for particular meetings of shareholders.
- 73.444.4 An appointment of an attorney or representative must be in a form approved by the Directors.
- 73.544.5 An appointment of a proxy is valid if it is signed by the shareholder making the appointment and it contains the following information:
 - 73.5.144.5.1 the shareholder's name and address;
 - 73.5.244.5.2 the Company's name;
 - 73.5.344.5.3 the proxy's name or the name of the office held by the proxy;
 - 73.5.444.5.4 the meetings at which the appointment may be used.

The Directors may decide to accept a proxy even if it contains only some of that information.

- 73.644.6 Unless otherwise specified in the appointment, the proxy, attorney or representative may:

 - 73.6.244.6.2 even if the appointment directs how to vote on a particular resolution:

- (a) vote on an amendment to the particular resolution, a motion not to put the particular resolution or any similar motion:
- (b) vote on a procedural motion, including a motion to elect the <u>chairpersonchairman</u>, to vacate the chair or adjourn the meeting;
- 73.6.344.6.3 speak at the meeting;
- 73.6.444.6.4 vote (but only to the extent allowed by the appointment);
- 73.6.544.6.5 request or join in a request for a poll.
- 73.744.7 If a person represents 2 or more shareholders, that person has only one vote on a show of hands.
- 73.844.8 If a shareholder appoints 2 proxies or 2 attorneys in one instrument and both are present, on a show of hands only the first named proxy or attorney may vote.
- 73.944.9 The appointment may specify the proportion or number of votes that the proxy or attorney may exercise. If the shareholder appoints 2 proxies or 2 attorneys and the appointment does not specify the proportion or number of the shareholder's votes each proxy or attorney may exercise, on a poll each proxy or attorney may exercise half of the votes.
- 73.1044.10 A later appointment of a proxy or attorney revokes an earlier one if both appointments could not be validly exercised at the meeting.

Part 6 - Directors

75.46. Number of directors

76.47. Appointment of directors

Unless the Director is the Managing Director and the Listing Rules do not require that Director to be subject to retirement, a Director appointed under this clause will hold office until the end of the next annual general meeting of the Company, at which the Director may be re-elected.
- 76.347.3 The Company in general meeting may appoint a director.
- 76.447.4 A person is eligible for election as a director at a general meeting only if:
 - 76.4.147.4.1 the person is a director retiring under the next clause and notifies the Company that he or she is available for re-election; or
 - 76.4.247.4.2 the person has signed a consent to nomination and lodged it at the Company's registered office.

The Company must accept these notices and nominations up to 35 Business Days (or in the case of a meeting that shareholders requested the Directors to call, 30 Business Days) before the general meeting. The Directors may decide to accept these notices and nominations closer to the date of the general meeting.

76.5 Without limiting the previous sub-clause, a person who has attained the age of 72 years is eligible for election as a director until the next annual general meeting, only if the Company gives notice to shareholders as required by the *Corporations Act 2001* and the Company in general meeting passes a resolution as required by the *Corporations Act 2001*.

77.48. Compulsory retirement

- 85.0 The directors who must retire under clause 49.1.3 are those directors who have been longest in office since their appointment on registration or their last election (whichever is later). If they became directors on the same day, they may agree who retires. If they do not agree, they may select by lot who retires.
- 86.0 This clause does not apply to the managing director.

87.49. Vacation of office

A director ceases to be a director if:

87.149.1 the Corporations Act 2001 so provides;

87.249.2 the director resigns by notice to the Company;

- 87.349.3 the Company in general meeting removes the person as a director:
- 87.449.4 the director is absent, without the consent of the Directors, from all Directors' meetings over any 6 month period;
- 87.549.5 the director becomes mentally incapable and the director's estate or property has had a personal representative or trustee appointed to administer it; or
- <u>87.649.6</u> the director automatically retires under the previous clause.

88.50. Alternate directors

- 88.150.1 A director may appoint an alternate for a specified period with the consent of the Directors.
- The appointor may terminate the alternate's appointment at any time.
- 88.350.3 An appointment or termination is effective only if:
 - 88.3.150.3.1 it is in writing;
 - 88.3.250.3.2 the appointor signs it; and
 - 88.3.350.3.3 the Company is given notice of it.
- 88.450.4 The alternate need not be a shareholder or director of the Company.
- 88.550.5 The alternate is entitled to notice of Directors' meetings.
- 88.650.6 If the appointor is not present, the alternate may:
 - 88.6.150.6.1 attend the Directors' meeting, count in the quorum, speak, and vote in the place of the appointor;
 - 88.6.250.6.2 exercise any other powers (except the power to appoint an alternate) that the appointor may exercise.
- 88.750.7 A person may act as an alternate for more than one director.
- 88.850.8 If the appointor ceases to be a director, the alternate cannot exercise the appointor's powers.
- 88.950.9 Where:
 - 88.9.150.9.1 an appointor ceases to be a director; and
 - 88.9.250.9.2 that appointor's alternate purports to do an act as a director;

that act is as valid, in relation to a person dealing with the Company in good faith and for value and without actually knowing that the appointor has ceased to be a director, as if the appointor had not ceased to be a director.

- 88.1050.10 The Company may pay an alternate any remuneration the Directors decide, in reduction of the appointor's remuneration.
- 88.1150.11 While acting as a director, an alternate is an officer of the Company and not the agent of the appointor.

89.51. Remuneration

- 89.151.1 The Company may remunerate each director as the Directors decide, but the total amount of the remuneration of non-executive directors may not exceed the amount fixed by the Company in general meeting for that purpose.
- 89.251.2 A director's remuneration may be any combination of:

- 89.651.6 If a director performs extra or special services for the Company, the Company may pay to the director any special remuneration the Directors decide, in addition to the director's normal remuneration.
- 89.751.7 The Company may pay a former director, or the estate of a director who dies in office, a benefit for past services as the Directors decide. This must not exceed the amount permitted by the Corporations Act 2001 and the Listing Rules.
- 89.851.8 The Company may establish or support superannuation or similar funds for the directors, as the Directors decide.

90.52. Share qualification

91.53. Director's interests

 - 91.1.153.2.1 hold an office or place of profit (except as auditor) in the Company, on any terms the Directors decide;

- 91.253.3 Subject to the Corporations Act 2001 and the Listing Rules:

- 53.4 A Director who has a material personal interest in a matter that is being considered at a Directors' meeting must not:
 - 53.4.1 be present while the matter is being considered at the meeting; or

 - unless permitted to do so by the Corporations Act, in which case the Director may:
 - 53.4.3 be counted in determining whether or not a quorum is present at any meeting of Directors considering that contract or arrangement or proposed contract or arrangement;
 - 53.4.4 sign or countersign any document relating to that contract or arrangement or proposed contract or arrangement; and
 - 53.4.5 vote in respect of, or in respect of any matter arising out of, the contract or arrangement or proposed contract or arrangement.
- 91.2.853.5 A Director must give to the Company such information about the shares or other securities in the Company in which the Director has a relevant interest and at the times that the Secretary requires, to enable the Company to comply with any disclosure obligations it has under the Corporations Act or the Listing Rules.

Part 7 - Proceedings of Directors

92.54. Circulating resolutions

55A Use of Technology for Holding Directors' Meetings

- 55A.1 Nothing contained in this Constitution shall be taken to prevent the use of virtual meeting technology to be used in holding of a meeting of directors—Directors (including a meeting of a committee of directorsDirectors) where the same is permitted by law.
- The provisions of this Constitution in relation to the holding of meetings of directors Directors (including a meeting of a committee of directors Directors) and the giving of notices of meetings of directors Directors (including a meeting of a committee of directors Directors) and any other relevant documents to directors Directors shall be modified to the extent necessary to permit the use of virtual meeting technology in accordance with the provisions of law that apply to such meetings.

93.<u>55.</u> Meetings

- 93.155.1 The Directors may meet, adjourn and otherwise regulate their meetings as they decide.
- 93.255.2 A Directors' meeting may be held using any technology consented to by all the directors. The consent may be a standing one. A director may only withdraw consent within a reasonable period before the meeting.
- 93.355.3 If a Directors' meeting is held by telephone link-up or other contemporaneous audio or audio visual communication, a director is taken to be present unless the director states to the chairman chairperson that the director is disconnecting his or her telephone or communication device.

94.56. Calling meetings

- 94.156.1 Any director may call a Directors' meeting.
- 94.256.2 On the request of any director, the company secretary must call a Directors' meeting.

95.57. Notice

- 95.157.1 Notice of a Directors' meeting must be given to each director and each alternate.
- 95.257.2 The notice must:
 - 95.2.157.2.1 specify the day, time and place of the meeting;
 - 95.2.257.2.2 state the business to be transacted;
 - 95.2.357.2.3 be given at least 48 hours before the meeting, unless all directors otherwise agree.
- 95.357.3 Non-receipt of notice of a meeting, or failure to give notice of a meeting to a director or an alternate, does not invalidate anything done at the meeting if:
 - 95.3.157.3.1 the failure was accidental;
 - 95.3.257.3.2 the director or alternate gives notice to the Company that he or she waives the notice or agrees to the thing done at the meeting; or
 - 95.3.357.3.3 the director or alternate attends the meeting.

96.58. Quorum

- 96.158.1 The quorum for a Directors' meeting is 3 directors, unless the Directors otherwise decide.
- 96.258.2 In determining whether a quorum is present, the chairman must count alternates. If a director is also an alternate, the chairman must count the director as a director and separately as an alternate. If a person is an alternate for more than one director, the chairman must count the person separately for each appointment.
- 96.358.3 The quorum must be present at all times during the meeting.
- 96.458.4 If there are not enough directors in office to form a quorum, the remaining directors may act only:
 - 96.4.158.4.1 to increase the number of directors to a quorum;
 - 96.4.258.4.2 to call a general meeting of the Company; or
 - 96.4.358.4.3 in an emergency.

97.59. Chairperson Chairman and deputy chairperson chairman

- 97.159.1 The Directors may elect a director as <u>chairperson chairman</u> for any period they decide.
- 97.259.2 The Directors may elect a director as deputy chairperson chairman for any period they decide.
- 97.359.3 The Directors may remove the chairperson chairman or deputy chairperson chairman.
- 97.459.4 The Directors may decide that either office is an extra or special service for the Company, for the purpose of deciding special remuneration.

- 97.559.5 The chairperson chairman is entitled to chair each Directors' meeting.
- 97.659.6 If there is no chairmen, or if the chairmen is not present within 10 minutes after the time appointed for the meeting or is unable or unwilling to act, the deputy chairmen may chair the Directors' meeting. If there is no deputy chairmen is not present within 10 minutes after the time appointed for the meeting or is unable or unwilling to act, the directors present must elect one of themselves to chair the meeting.
- 97.759.7 If the <u>chairperson chairman</u> is unable or unwilling to chair a part of the meeting, the deputy <u>chairperson chairman</u> may chair that part. If there is no deputy <u>chairperson chairman</u>, or the deputy <u>chairperson chairman</u> is unable or unwilling to act, the directors present must elect one of themselves to chair that part.

98.60. Decisions of Directors

- 98.160.1 Subject to the Corporations Act 2001, each director has one vote.
- 98.260.2 If a director is also an alternate, the director has one vote as a director and one vote as an alternate. If a person is an alternate for more than one director, the person has one vote for each appointment.
- 98.360.3 A resolution of the Directors is passed by a majority of votes cast.
- 98.460.4 Subject to the Listing Rules, the <u>chairperson chairman</u> has a casting vote, if the <u>chairperson chairman</u> has a personal deliberative vote.

Part 8 - Directors' powers

- 100.2.262.2.2 a director and a company secretary of the Company.
- The Company may execute a document only if authorised by the Directors or by a committee of directors authorised by the Directors to do so.
- 100.462.4 The Directors may decide, generally or in a particular case, that a director or company secretary may sign certificates for securities of the Company by mechanical or other means.
- 100.562.5 This clause does not limit the ways in which the Company may execute a document (including a deed).
- 101.0 The Company may execute a document in any manner permitted by law including in the manner set out in subsections (3A), (3B) and (3C) of the Corporations Act, 2001.

102.63. Negotiable instruments

The Directors may decide how negotiable instruments (including cheques) may be signed, drawn, accepted, endorsed or otherwise executed.

103.64. Committee and delegate

- 103.164.1 The Directors may delegate any of their powers (including this power to delegate) to a committee of directors or to one director.
- 103.264.2 The Directors may revoke or vary that delegation.
- 403.364.3 A committee or delegate must exercise the powers delegated subject to any directions of the Directors. The effect of the committee or delegate exercising a power in this way is the same as if the Directors exercised it.
- 103.464.4 Part 7 applies with the necessary changes to meetings of a committee.
- 103.564.5 The Directors may decide that membership of a committee or acting as a delegate is an extra or special service for the Company, for the purpose of deciding special remuneration.

104.65. Attorney and agent

- 104.165.1 The Directors may appoint any person to be the attorney or agent of the Company for any purpose, for any period and on any terms (including as to remuneration) the Directors decide.
- 104.265.2 The Directors may delegate any of their powers (including the power to delegate) to an attorney or agent.
- 104.365.3 The Directors may revoke or vary:
 - 104.3.165.3.1 the appointment; or
 - any power delegated to the attorney or agent.

Part 9 - Executive officers

105.66. Managing director

- 105.166.1 The Directors may appoint one of themselves as managing director, for any period and on any terms (including as to remuneration) the Directors decide.
- 405.266.2 Subject to any agreement between the Company and the managing director, the Directors may remove or dismiss the managing director at any time, with or without cause.
- 105.366.3 The Directors may delegate any of their powers (including the power to delegate) to a managing director.
- 105.466.4 The Directors may revoke or vary:
 - 105.4.166.4.1 the appointment; or
 - 105.4.266.4.2 any power delegated to the managing director.
- 105.566.5 A managing director must exercise the powers delegated subject to any directions of the Directors. The effect of the managing director exercising a power in this way is the same as if the Directors exercised it.
- 105.666.6 A person automatically ceases to be managing director if the person ceases to be a director or an executive of the Company.

106.67. Executive director

A person automatically ceases to be an executive director if the person ceases to be a director or an executive of the Company.

107.68. Company secretary

- 107.168.1 The first company secretary of the Company is the person specified in the application for registration of the Company as company secretary.
- 107.268.2 The Directors may appoint one or more company secretaries, for any period and on any terms (including as to remuneration) the Directors decide.
- 407.368.3 Subject to any agreement between the Company and the company secretary, the Directors may remove or dismiss the company secretary at any time, with or without cause.

108.69. Indemnity

The Directors may:

 - to forego a Dividend from the Company in place of another distribution from the Company or another body corporate or a trust;

122.82. Unclaimed Dividends

Unless proved incorrect, the register of shareholders is sufficient evidence of the matters shown in the register.

132.92. Minute book

- 132.192.1 The Company must keep minute books in which it records within one month:
 - <u>132.1.192.1.1</u> proceedings and resolutions of meetings of the shareholders;
 - proceedings and resolutions of Directors' meetings (including meetings of a committee of Directors);
 - resolutions passed by shareholders without a meeting;
 - resolutions passed by directors without a meeting.
- The Company must ensure that minutes of a meeting are signed within a reasonable time after the meeting by one of the following:
 - 132.2.1<u>92.2.1</u> the chair of the meeting;
 - the chair of the next meeting.

132.392.3 The Company must ensure that minutes of the passing of a resolution without a meeting are signed by a Director within a reasonable time after the resolution is passed.

133.93. Evidence of minutes

A minute that is so recorded and signed is evidence of the proceeding, resolution or declaration to which it relates, unless the contrary is proved.

134.94. Financial records

- 134.194.1 The Company must keep the financial records required by the Corporations Act-2001.
- 134.294.2 The financial records must be audited as required by the Corporations Act 2001.

135.95. Inspection

Unless authorised by the Directors or the Company in general meeting or the Corporations Act-2001, a shareholder is not entitled to inspect the Company's books.

Part 13 - Notices and interpretation

136.96. In writing

Notice must be in writing and in English, and may be given by an authorised representative of the sender.

97. Notice to shareholders Service of Notices

- 97.1 A **Notice** includes a notice, demand, consent, approval or communication under this Constitution and a reference in this Constitution to a written notice includes a notice given by electronic means.
- 97.2 Subject to (and without limiting any other way in which a notice may be given, or is required to be given, under) this Constitution, the Corporations Act and the Listing Rules, a Notice may be given by the Company to any person who is entitled to notice under this Constitution by:
 - 97.2.1 sending the Notice in physical form by post, by hand or by courier to the Member's address in the Register (or any other address the Member supplies to the Company for giving Notices); or
 - 97.2.2 sending the Member sufficient information in physical form by post, by hand or by courier to the Member's address in the Register (or any other address the Member supplies to the Company for giving Notices) as to allow the Member to access the Notice electronically; or
 - 97.2.3 sending the Notice in electronic form by means of an electronic communication to the electronic address the Member has supplied to the Company for giving Notices; or

- 97.2.4 sending the Member sufficient information in electronic form, by means of an electronic communication to the electronic address the Member has supplied to the Company for giving Notices, as to allow the Member to access the Notice electronically; or

 - 97.3.4 if the Notice is one that is referred to in clause 97.2.5 and is given in accordance with clause 97.2.5, on the day on which the Notice first appears on the relevant website, except if the Notice first appears on the relevant website after 5.00pm (in the place from which the Notice is uploaded to the relevant website) in which case, it is taken to be served on the next day.
 - 136.1.1 A notice may be served by the Company on joint holders under clause 97.2.1 or 97.2.2 by giving the notice to the joint holder whose name appears first in the Register.

- 97.3.6 Every person who is entitled to a share by operation of law and who is not registered as the holder of the share is taken to receive any notice served in accordance with this clause by advertisement or on that person from whom the first person derives title.

- 145.0 A person, entitled to a share because of a transfer, Transmission Event or otherwise, is bound by every notice given in respect of the share.

146. Notice to directors

- 163.0 A notice sent by fax, or other electronic means, is taken to be given on the Business Day after it is sent (if the sender's transmission report shows that the whole notice was sent to the correct facsimile number).

164.98. CHESSASX Settlement Operating Rules

While any securities in the Company are CHESS Approved Securities Holdings, the Company must comply with the CHESS ASX Settlement Operating Rules.

165.99. Interpretation

- 99.8 A reference in this Constitution to a Member being present at a meeting of Members is a reference to:
 - 99.8.1 a Member present at the physical venue (or a physical venue)

 - 99.8.2 a Member present by proxy, attorney or representative (whether such proxy, attorney or representative is present at the physical venue (or a physical venue) (if any) for the meeting

ASX Settlement Operating Rules means the operating rules of ASX Settlement as amended or replaced from time to time, except to the extent of any express written waiver by ASX Settlement;

Business Day means:

- (a) while the Company is admitted to the official list of ASX, Monday to Friday inclusive, except New Year's Day, Good Friday, Easter Monday, Christmas Day, Boxing Day, and any other day that ASX declares is not a business day;
- (b) while the Company is not admitted to the official list of ASX, any day except a Saturday or Sunday or other public holiday in New South Wales:

Marketable Parcel has the same meaning as in the ASX Settlement Operating Rules in force from time to time;

Member means a person who is a member of the Company under the Corporations Act;

Register means the register of Members of the Company;

Restriction Agreement means a restriction agreement within the meaning of the Listing Rules;

Secretary means any person appointed by the Directors to perform any of the duties of a secretary of the Company and if more than one person is appointed, any one or more of such persons;

SCH means ASX Settlement and Transfer Corporation Pty Ltd ACN 008 504 532 as approved as the securities clearing house under the *Corporations Act* 2001;

SCH Business Rules means the business rules made by SCH;

Spouse of a person means:

- (a) that person's husband, wife, widow or widower (whether or not remarried);
- (b) anyone else who, although not legally married to that person, in the Directors' opinion, lives or lived with that person on a genuine domestic basis as the husband or wife of that person; and

Transmission Event means:

- (a) if the shareholder is an individual death, bankruptcy, or becoming of unsound mind or becoming a person whose property is liable to be dealt with under a law about mental health;
- (b) if the shareholder is a body corporate the deregistration or winding up of the shareholder or the succession by another body corporate to the assets and liabilities of the shareholder.
