ABx Group Adopts Global Standard for ESG Reporting

ABx Group has commenced disclosing environmental, social, and governance (ESG) metrics, using the internationally accepted Stakeholder Capitalism Metrics developed by the World Economic Forum

ABx Group has subscribed to Socialsuite's reporting platform to assist with monitoring and disclosing progress

It is intended to release a baseline ESG disclosure report during the quarter

ABx Group (ASX: ABX) ("ABx" or "the Company") is pleased to announce that it has adopted an Environmental, Social, and Governance (ESG) framework created by the World Economic Forum (WEF) and subscribed to Socialsuite's reporting platform to assist with monitoring and disclosing progress.

ABx Group Managing Director and CEO Mark Cooksey said:

"As part of our purpose of 'delivering materials for a cleaner future', ABx is committed to the principles of ESG. We have committed to commence disclosing our ESG progress against the Stakeholder Capitalism Metrics developed by the World Economic Forum.

"To assist in this process, we have subscribed to Socialsuite's reporting platform, as it enables small to mid-cap companies to complete their ESG reporting in a structured, standardised, and globally recognised manner. The Socialsuite platform excels in making the World Economic Forum framework accessible and operational and we will use it to demonstrate our ESG performance and share our journey of building robust ESG credentials."

COMMENCING ESG REPORTING

The two main areas of focus for ABx are:

- Creation of a rare earths project, to enable the increased production of permanent magnets, essential for renewable energy generation, and
- Establishment of a plant to produce hydrogen fluoride and aluminium fluoride from recycled industrial waste

These two areas have very strong ESG credentials, but ABx also recognises that there are more aspects to ESG and there is value in providing more transparent and comprehensive disclosure to stakeholders.

By including ESG metrics in mainstream reporting and integrating them into governance, business strategy, and performance management process, ABx aims to demonstrate that it diligently considers all pertinent risks and opportunities for its business. ABx will demonstrate ongoing commitment to ESG by describing its progress in periodic updates in the public domain.



UNIVERSAL ESG METRICS

ABx has resolved to disclose against the World Economic Forum (WEF) Stakeholder Capitalism framework. This framework comprises a set of 21 core metrics for sustainable value creation and leverages a variety of existing frameworks. It is intentionally built to be a stepping-stone to begin building capacity and capability in ESG reporting.

It enables ABx to report on core ESG matters such as governance, anti-corruption practices, ethical behaviour, human rights, carbon emissions, land use, ecological sensitivity, water consumption, diversity, and inclusion, pay equality and tax payments.

STANDARDISED DISCLOSURE TECHNOLOGY

ABx has subscribed to the Socialsuite reporting platform to build towards a baseline ESG disclosure report. The Company envisages this to be released during the quarter.

Subsequently, the Company will focus on utilising Socialsuite to deliver and report ongoing progress toward improving ESG metrics and indicators. The Socialsuite platform is an efficient way for investors and other stakeholders to assess the commitment and progress of the Company on its journey to improve EG outcomes.

ESG GAP ANALYSIS

The first step in ABx's ESG journey was to conduct an ESG gap analysis and determine how ABx stands in relation to the ESG framework's 21 core metrics. Our status is captured in the attached snapshot of our ESG Progress Dashboard. This demonstrates our intent to proactively and transparently describe our ESG progress.

- Mining and enhancing the value of bauxite resources for cement, aluminium, and fertilisers.


